Each year we sign a memorandum of agreement with our partner organization in Nepal, Bhuwaneshwori Satyal Foundation, which includes a budget. We provide funds for program services and oversight to all these services. We receive monthly reports, reconciled bank statements, and an accounting of all petty cash spent. This is monitored and overseen by a Napalese accountant here in the USA and reconciled with our accounting records. The documents are reviewed by the finance committee on a quarterly basis.
