In 2015 the organization received an \$80,000 contribution and in 2016 a \$68,000 contribution, the total of which equals the permanent endowment. The earnings on the investments, less investment fees, are to be used for scholarships for children in Nepal who evidence the most financial need. In 2015 none of the earnings was used for scholarships since the market value of the publicly-held investments was less than the original contribution. At 12/31/16 the market value of the investments and their earnings exceeded the permanent portion of the endowment. However, the board determined that the excess wasn't sufficient to award any scholarship in 2016 so the amount was carried over to 2017 and is considered Temporarily restricted net assets. The endowment is noted in Part X, line 28 (Temporarily restricted) and line 29 (Permanently restricted). According to the terms of the endowment contributions, in the first quarter of the each year, the organization will calculate the

excess of the previous year's endowment fund's balance over the corpus. During the second quarter of the year, the organization will transfer that excess into its operating bank account, 10% of which can be used as unrestricted funds and 90% which is set aside for the benefit of the designated children.
