university level in the Kathmandu Valley. We provided oversight and program coordination for our programs in partnership with our major NGO partner in Nepal, Bhuwaneshwori Satyal Foundation (BSF). Due to the pandemic, which resulted in extreme hardships from lockdowns, school and business closings, and political unrest, our funding shifted to providing emergency food and supplies, reorganizing children's living situations to safe housing and providing devices/methods for online learning and continued educational and counseling/social work services to the children and their families. The following are pandemic-related accomplishments: 1. Built and distributed emergency supply kits for children's families for ten months; 2. Covid tested children and provided emergency medical care to family members and children; 3. Retrofitted the Contact Center to provide in-person socially-distanced, targeted educational instruction; 4. Expanded emergency housing to accommodate children without housing once schools closed; 5. Linked as many children as possible to a form of virtual learning, supplying cell phones and laptops; and 6. Prioritized continuous counseling and in-person check-ins with families at great personal risk to BSF staff. CONTACT CENTER: The Contact Center, located in Balaju, Kathmandu, is a day educational program which prepared 22 children of varying young ages to attend school for the first time. The population served includes children documented to be from low SES families such as itinerant workers or migrants. Due to the pandemic, new children were not able to be admitted to the program. Children who were set to graduate remained under the Contact Center teacher tutelage in order to prepare them for entry to private school the following year. Schools were not open to new admittance due to the pandemic and lockdowns. CHILD SPONSORSHIP PROGRAM: We obtained three new sponsors for our children this year and all children are currently sponsored. Elementary School children: We supported 26 children in Class UKG through Class 10 for both housing and education, attending boarding schools (or emergency housing) throughout the Kathmandu Valley. We supported

another 27 children who lived at home for their education. All of our children finishing Class 10 passed the Secondary School Exam (SEE) the first time and continued to Class 11, moving to a new school in order to focus on a particular field of study. 11th-12th Grade Children - We supported 21 children in 11th and 12th grade in various schools. Post 12th Grade Children - Through an individualized approach and our commitment to support each child into adulthood, in spite of the pandemic, most of our children progressed on to further education. Twenty children enrolled in universities in the fields of social work, education, computer engineering, nursing, dental surgery, medicine, and hotel and business management.

GRADUATES FROM OUR PROGRAM: Although we had older children who were completing their educational programs in spite of the pandemic, we did not formally graduate any children from Mitrata, as they continued to need economic, social service and housing support due to the pandemic. We also supplied emergency rations to some of our previous Mitrata graduates. **HEALTHCARE CAREER STUDENTS:** Because healthcare career college tuitions in Nepal are considerably higher than other college programs (ranging from 7,000 - 50,000 USD), Mitrata fundraises specifically to support children with these career goals. We support two students who are now fully-funded and progressing well in school. One student completed his sixth year in medical school and one student her fifth year in dental surgery. Our mission focuses on individualized education to help children reach their potential and includes the added goal of helping to meet Nepal's larger societal need for well-trained professionals. **MORE SUPPORT SERVICES:** Intensive counseling and support services were provided to many families struggling with the hardships due to the pandemic. Family members did not have working members and children were not in formal school much of the time. As a result, BSF staff greatly increased their home social services and deliveries of supplies and counseling services. **AFTER SCHOOL PROGRAM:** The after school program continued with teachers meeting in one

on one sessions, socially distanced and providing supplies for school. SCHOLARSHIP

FUND: We continued this fund. With many children going on to college and rising inflation rates, we recognize the need to help offset the extra costs to care for children of college age. Many colleges add extra fees for exams, preparatory courses, internships and field trips, and often require laptop computers. ENDOWMENT

FUND: We continued to manage this fund which is held in perpetuity and invested, with the annual returns used to provide scholarships for our children. CONTACT

CENTER EXPANSION FUND: We completed our fundraising for the expansion and addition plan for the Contact Center. The five-year strategic plan has been postponed due to the pandemic but remains to be implemented as soon is BSF is capable and able to move forward. CULTURAL AND OVERSIGHT TRIPS: One trip to Nepal was completed by two Board members, Rick Hendin and Jim Craig. They left a few days early to return home just in time before the first lockdown in March in Nepal.

USA FUNDRAISING AND COMMUNITY AWARENESS EVENTS: Although in person community awareness events were not possible, Mitrata completed four new sponsor story videos for our website. Mitrata re-envisioned two successful fundraising events to a virtual format. The Trivia Night was held in August and Miles for Mitrata Kids was held in September. We developed an e-commerce platform to take the place of an in-person Holiday Bazaar. USA OPERATIONAL ACCOMPLISHMENTS: We successfully transitioned to a new donor database requiring many months of work. Due to the lack of fundraising dollars in the first half of the year, we successfully applied for and received a small PPP loan to cover employee payroll for two months. We continued to maintain a Gold rating on Guidestar and to be approved by the Better Business Bureau. NON-VOTING ADVISORY AND YOUNG PROFESSIONAL BOARDS: We added a Nepali physician to our volunteer advisory board to make a total of eight advisors, and we established a group of five Young Professional volunteers.
