Pt VI, Line 19: Our 990 is available on Candid (formerly GuideStar) and upon request, and our past few 990's and financial statements are included on our website. Other governing documents are available upon request. We have met the "20 Standards for Charity Accountability" and are an accredited charity of the Better Business Bureau (BBB).

Other: Pt. XII, line 2a and 2c - Our CPA provides preparation engagement statements which are comparable to compiled statements. The executive committee is responsible for monitoring the accounting processes and selecting who provides the accounting for the organization.

Other: Pt. III, line 4a - Statement of Program Accomplishments - OVERVIEW: We provided funding for programs in education, healthcare, housing, and support services for 118 underprivileged children ranging from preschool age through

university level in the Kathmandu Valley. We provided oversight and program coordination for our programs in partnership with our major NGO partner in Nepal, Bhuwaneshwori Satyal Foundation (BSF). In Nepal, our children finished the school year and advanced to higher grades, despite difficulties with remote learning and unstable home lives. Further, we had six graduates who obtained jobs and became independent of Mitrata support. BSF staff, while facing so many problems amid rising COVID-19 cases, delivered care packages to our children's families, and moved both the Contact Center and their offices to much improved buildings. Additional accomplishments are: (1) Vaccinated BSF staff and older children; (2) Secured necessary emergency bedding to accommodate children without housing after schools closed; (3) Supplied cell phones and laptops to children in need; (4) Cared for children and staff who contracted Covid and other illnesses due to poor living conditions; (5) Turned Contact Center into an emergency supply distribution center and quarantine zone for children coming from villages; (6) Set up an emergency housing apartment for children who had no where to go when schools were shut down for months; (7) Reopened the Contact Center to offer online and in-person classes; (8) Graduated five Contact Center children to join area boarding schools; (9) Celebrated all 10th graders passing SEE exams to enter 11th grade, continuing our success rate of 99%; (10) Gained two new child sponsors; (11) Engaged four sponsors, whose children graduated, to take on support of new children; (12) Hosted Virtual Trivia Night and Miles for Mitrata Kids fundraisers; (13) Hosted Virtual Sponsor Ice Cream Social; and (14) Raised funds for a vehicle for BSF to transport our children and families. CONTACT CENTER: The Contact Center, located in Kathmandu, is a day educational program which prepared 20 children of varying young ages to attend school for the first time. The population served includes children documented to be from low SES families such as itinerant workers or migrants. By the end of 2021, BSF and Mitrata had achieved two important goals of our five-year strategic plan: namely, (one) procuring

a new, larger building to expand our current Contact Center with space for our after-school programs and older children's transitional housing apartments, outdoor areas for play and enrichment, and a driveway or parking; and (two) raising \$125,000 to identify, secure, and set up a second Contact Center that will enable us to expand our programming into another impoverished Kathmandu neighborhood. CHILD SPONSORSHIP PROGRAM: We obtained two new sponsors for our children this year and all children are currently sponsored. Elementary School Children: We supported 30 children in Class UKG through Class 10 for both housing and education, and attending boarding schools (or emergency housing) throughout Kathmandu Valley. We supported another 26 children who lived at home for their education. All of our children finishing Class 10 passed the Secondary School Exam (SEE) the first time and continued to Class 11, moving to a new school in order to focus on a particular field of study. 11th-12th Grade Children: We supported 14 children in 11th and 12th grades in various schools. Post 12th Grade Children: Through an individualized approach and our commitment to support each child into adulthood, despite the pandemic, most of our children progressed onto further education. Twenty-eight children attended universities in the fields of social work, education, computer engineering, nursing, dental surgery, medicine, hotel, and business management. GRADUATES FROM OUR PROGRAM: We had six children who completed their education and were able to obtain jobs and become independent of Mitrata. HEALTHCARE CAREER STUDENTS: Because healthcare career college tuitions in Nepal are considerably higher than other college programs (ranging from 7,000 - 50,000 USD), Mitrata fundraises specifically to support children with these career goals. We support two students who are now fully-funded and will complete their programs in 2022. MORE SUPPORT SERVICES: Although schools and businesses reopened, many of our families continued to struggle financially and needed much more social, emotional, and environmental support. Throughout 2021, BSF staff kept our children engaged

in school, provided emergency food and supply kits, and mitigated crisis situations through counseling and support. They set up COVID-19 quarantine space for children coming from outside Kathmandu, operated two group facilities for children without suitable homes, and coordinated with families and schools to ensure that students continued their education and completed their online exams. AFTER SCHOOL PROGRAM: The after-school program reopened. SCHOLARSHIP FUND: We continued with this fund. With many children going on to college, and rising inflation rates, we recognize the need to help offset the extra costs to care for children of college age. Many colleges add extra fees for exams, preparatory courses, internships, and field trips, and often require laptop computers. ENDOWMENT FUND: We continued to manage this fund, which is held in perpetuity and invested, with the annual returns used to provide scholarships for our children. CULTURAL AND OVERSIGHT TRIPS: There were no trips in 2021 due to COVID-19. USA FUNDRAISING AND COMMUNITY AWARENESS EVENTS: Although in-person community awareness events were not possible, Mitrata hosted two successful virtual fundraising events, The Trivia Night and Miles for Mitrata Kids. We held a virtual Sponsor Ice Cream Social. USA OPERATIONAL ACCOMPLISHMENTS: We successfully operated two virtual fundraisers, maintained our donor and sponsor base, and fundraised for an Annual Campaign to purchase a much-needed vehicle in Nepal. Despite economic challenges, we increased our revenue while lowering expenses. We continued to maintain a gold rating on Guidestar and to be approved by the Better Business Bureau. NON-VOTING ADVISORY AND YOUNG PROFESSIONAL BOARDS: We continued with eight Advisors and four Young Professional volunteers.
